The Chandler High School (CHS) Baseball Program is asking for your help in raising funds through the Arizona School Tax Credit Program (12/31/09 Postmark Deadline). As we attempt to keep costs to student-athletes as low as possible, our baseball program requires outside resources to assist with funding of team operations throughout the year. All financial resources are utilized towards providing our student-athletes the best high school athletic experience possible.

For 2009, Arizona Law ARS 43-1089.01 allows Arizona Taxpayers a tax credit contribution as follows:

- Married-Filing Joint Return -up to \$400.00 per calendar year
- Single or Head of Household -up to \$200.00 per calendar year
- Married filing separate -up to \$200.00 per calendar year each

Who Can Participate:

ANY INDIVIDUAL AZ TAXPAYER. Business donations or sponsorships are greatly appreciated but cannot be used to claim a School Tax Credit.

Examples of How it Works:

A) This is a **TAX CREDIT, not a deduction.** A tax credit is a **Dollar-for-Dollar reduction in the actual tax you owe.**

B) **What if I don't owe State taxes, or am entitled to a refund.** Can I still benefit from supporting CHS Baseball? YES, In supporting the School Tax Credit Program, an Arizona Taxpayer can go from owing the State money to receiving a refund or increasing their refund through their Arizona Tax Return:
